How to get to CJ Law Hall

By Subway

- ① If coming from Anam Station, Line 6
: leave the station from Exit 2 → Reach the university gate near the College of Political Science & Economics
→ Pass the College of Political Science & Economics → Pass the International Studies Hall
→ Pass behind the College of Liberal Arts → Follow foot path → Pass the Haesong Law Library
→ Arrive at the CJ Law Hall
- ② If coming from Korea University Station, Line 6
: leave the station from Exit 1 → Follow narrow path toward the university main gate
→ Pass the Business School Main Building (under construction) → Pass the Main Library
→ Pass the College of Law Annex Building → Arrive at the CJ Law Hall

By Car (cars cannot be driven around campus)

- : Main Gate → Park in underground parking lot → Main Hall → Graduate School → Haesong Law Library
→ The CJ Law Hall

By Taxi (taxis cannot be parked in front of the College of Law Building)

- ① If coming from Jegi-dong
: enter the byway across from Sungbuk Jungang Church and stop at gate next to the College of Law Building
- ② If coming from Mia-dong
: enter the byway directly in front of Alumni Hall and stop at gate next to the CJ Law Hall
